

DO YOU KNOW THESE **ORDINANCES?**

Certain ordinances are more commonly referenced by citizens than others. Here you will find brief descriptions of these particular ordinances. If you have further questions, please contact the City of Monroe Code Department at 770-207-4674 or permits@monroega.gov.



NOISE DISTURBANCES

It is unlawful, at any time of the day, to create loud or unusual noises that are detrimental or annoying to the public. Additionally, loud noises are prohibited between the hours of 11pm-7am.



!\UNSAFE STRUCTURES

Any building that endangers the life, health, property, or safety of its occupants or general public, as determined by the building inspector, is illegal and shall be immediately repaired, rehabilitated, or demolished. Any structure classified as uninhabitable must be vacated immediately.



PERMITS

Alterations to the structural integrity of a building must be permitted. Work on mechanical, electrical, and plumbing systems require a permit. Contact the City Code office for more info.



JUNK VEHICLES

Junk vehicles may not be parked, stored, or left on private or public property. A junk vehicle is any vehicle that does not have a current license plate lawfully displayed and is otherwise in bad repair, or is not fully operational, or is wrecked, dismantled, abandoned, or discarded.

COVERGROWN VEGETATION

It is unlawful for the owner, occupant, or agent of a lot to permit or maintain any growth of undesirable vegetation as determined by the City Code of Ordinances.



LEAF AND LIMB PICKUP

Leaves, limbs, and grass or other trimmings should be placed on the curbside for collection. A maximum of one truckload of leaf and limb material will be removed from residential curbsides per week. Individuals or companies under hire must remove all leaves, limbs and related debris from the property. Please contact Public Works at 770-267-6933 for scheduling pickup.



Golf carts may be operated within the city only after the owner has completed the registration process. Information can be obtained at the City Code office.



FIRES

Burn ban in effect May 1-Sept. 30 annually. More information at GATrees.org.



GARBAGE CONTAINER

All garbage containers must be stored in its normal location at the front-most wall of the building nearest the building line until pushed to the curb not earlier than 5:00 pm on the day before the date of collection and moved back from the right-of-way to its normal location by 5:00 pm the following day of collection.



BUSINESS OCCUPATION TAX

A business occupation tax certificate is required for each person engaged in business, trade, or occupation. The certificate must be displayed in the place of a business. Information may be obtained at the City Code office.

YARD SALES

A permit for each yard sale is required. 24 hours prior to conducting a sale, a permit shall be secured from City Hall. This permit shall be issued without charge.

Yard sales are allowed for not more than a total of 8 days in a calendar year. Permits are issued one or two day increments with a maximum of four sales per year. No sale may be conducted on Sundays. Sale times are limited to the hours between 7 am and 8 pm Monday through Saturday.
