#### Term

Effective Date through 6/30/2012

#### Territory

- The United States
- Some programming is restricted to the States of Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Virginia, and West Virginia

### Carriage Requirement

First or second most widely distributed package of services which meets a 90% penetration minimum

#### Local Avails

. Two (2) minutes per programming hour between 8am and Midnight

#### Surcharge

 MSO has option to accept or reject surcharge for additional professional or Division 1 collegiate men's sporting events programming

#### Cross Channel Promotion Discount

 Affiliate shall make at least 200 cross channel promotion spots per month available to Network, on a system-by-system basis.

#### Channel Position Discount

 Channel placement must be consistent throughout all systems, must be in the sports channel neighborhood and remain on the same channel throughout the Term

#### Creditworthiness Discount

Affiliate must pay all amounts due within 30 days of past due notification from Network.

### Term Length Discount

A discount is given if Affiliate agrees to carry network through 6/30/2012.
